- <u>Cross Country Covid-19 Increase Cost:</u> CAA Staff are requesting to increase the per athlete meet fee from \$10 to \$15 during the 2020 season to cover extra cost of chip timing at all meets. **APPROVED** - (7-0-0)
- <u>CAA Multicultural Committee</u> Zoom meetings scheduled resume committee goals, Zoom Student- Athlete Leadership Conference RISE, Review and Implement a state tournament Hate speech / Harassment policy
- <u>2020-2021 Transfer Rule Clarification</u> Current transfer bylaws will be enforced, Athletic Director's must submit a transfer appeal form if a student played the sport the previous school year and feels that they should be automatically eligible. August 1st, 2020 is the cutoff date for transfers to be enrolled, without having to site 50% of minimum schedule games.
