APPROVAL OF MINUTES

FINANCIAL REPORT:

APPEALS/ISSUES

- Our Lady of the Sun School Protest review Official scorebook had the incorrect amount of fouls listed for a player from their team. Head coach protested the amount of fouls on a player but the head referee stated that the home book was official. Protest was filed at that point. Decision: Denied game results stand.
- AZ Compass Prep High School Boys Open Basketball Team Violation Article 12: Head coach was ejected from the contest, unsportsmanlike acts continued as he was leaving the gym causing the game to be discontinued.

Corrective Action Plan: Az Compass Prep Athletic Director provided a detailed corrective action plan to the Executive Board.

Decision: Approve with conditions - program is placed on "Warning" for the remainder of the 2020-2021 season. Administration must attend all future CAA games that are remaining this season. Spectator Code of Conduct must be reviewed with all parents, zoom link emailed to the league office.
