Executive Director Report:

Season 1 State Tournaments (Junior High):

Several forfeits in baseball brackets after brackets announced led to several forfeits in the 2021 state tournament early rounds. Member schools should review team commitment 7 days prior to brackets being announced. Dropping out after takes spots away from potential teams to be able to compete and cost the association money. Schools who dropped will be fined per CAA bylaws at reconciliation.

5.2.1.1 Varsity athletes can be in grades 7-12.

5.2.1.1.1 Junior Varsity athletes can be in grades 7-11.

5.2.1.1.1.1 Seniors may appeal to compete at JV level. (w/appeal)

5.2.1.1.1.2 Junior Varsity athletes can play 6 quarters per day (Basketball)

5.2.1.1.1.3 Junior Varsity athletes can play 5 sets per day (Volleyball)

5.2.1.1.1.4 Refer to Article 4.5 for number of contests.

 Members who are in disagreement of these updates by the Executive Board should send in written notice to the league prior to 11/3/21. Members would need 51% to stop placement of these additions per CAA Constitution. <u>EduPrize - Gilbert Program</u> - Compliance Review - Placed on "Warning" for the remainder of the 2021-2022 school year.

<u>East Valley High School Flag Football</u> - Incident reported during a game vs A+ Charter in Maricopa involving the coaches and officials. Game was ended by the officials prior to completion due to sportsmanship issues. East Valley High School Flag Football team is placed on "**Advisement**" for the rest of the 2021 season.

Swimming Bylaw Review:

** Change the minimum number of meets required to "3" from 4.

28.7.4 Swimmers must have competed in at least 3 CAA approved meets during the season to be eligible for the State Championship. (2021 Season) APPROVED

<u>High School Fall Season Minimum Game Update</u>: The Executive Board has reviewed the Covid-19 impact on the Fall season and has changed the minimum number of games required to qualify for state playoffs if a cancellation was due to a Covid positive/close contact issue.

- Boys Soccer 8 games
- HS Football: D.1 5 games, D.2 6 games

Junior High Tackle Football - Article 5 update.

• 5.2.2.1.2 Junior High Tackle athletes must be 6-8th grade only.

<u>BASIS - Scottsdale Volleyball Game</u> - Incident report was sent in by Imagine Superstition about spectator conduct at an away game vs BASIS - Scottsdale. Board recommends that the school send out a reminder about the CAA Spectator Code of Conduct. Admin. from BASIS did respond to parent emails and have addressed the incident.
