New Business:

New Way Academy - Varsity Football - Appeal 8.2.1.1

2023 High School Football schedule was released with a mandatory game vs Skyline Prep High School, AD informed the CAA and Skyline Prep that they would not be playing this game due to safety concerns that happened during previous games. Skyline Prep did not agree with this decision and stated that the game should be played. Appeal was filed by New Way Academy AD, reviewed by Executive Board and a decision was made.

Executive Board Decision:

Article 8.2 Failure to schedule a mandatory game

New Way Academy High School Football program is placed on "Warning" for the 2023-2024 school year for failure to schedule a mandatory football game vs Skyline Prep High School.

Per Article 8.2.1.1.1

New Way Academy will be ineligible for the 2023 postseason.

Skyline Prep High School does not agree with this cancellation, and according to bylaws, the following fine will be assessed to New Way Academy.

10.4.3 Failure to Travel for a Mandatory Game

10.4.3.1 If the game is not completed as scheduled, a \$750 fine will be imposed on the visiting team with \$700 paid to the team that was canceled upon. A hardship must be proven as to why travel is not possible.

Reported violation of Article 8.6.2:

Junior high boys basketball program competed in 18 regular season games.

Article 12 Sportsmanship - Coach and Administrator

During the 2023 Spring season, Coed Soccer State Championship Game the head coach was ejected from the game for unsportsmanlike conduct during the 2nd half. Play continued with the athletic administrator coaching the team, he was ejected a few minutes later for unsportsmanlike conduct toward a game official.
