NEW BUSINESS :

SchoolFundr / CAA Scholarship Program -

Launched this month with our new sponsorship partner - Schoolfundr is helping the CAA with our first ever scholarship program to help support student athletes financially going to the next level. A committee will be formed to oversee the application process and awarding the money to several students in early May of 2024.

Abundt Health - Health Box Program:
